14		Office of the Treasurer FY 2025 budget by \$1,077,648.17 from \$1,891,819.54 to
15		\$2,969,467.71; and
16	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2025 Office of the
17		Treasurer Budget Amendment No. 1 and recommends its approval.
