

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Planning and Economic Development Department Roads Program
Contract between the Tohono O'odham Nation and Black and Yellow Paving LLC)

RESOLUTION NO. 25-207

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "[t]o consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council" (Constitution of the Tohono O'odham Nation, Article**
7 **VI, Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
9 **within the exclusive control of the Tohono O'odham Nation ... and to appropriate**
10 **these funds for the benefit of the nation and its members" provided that "[a]ll**
11 **expenditures of these funds shall be pursuant to appropriations or budgets"**
12 **authorized by resolution or ordinance (Constitution, Article VI, Section 1(d)(2));**
13 **and**

14 **WHEREAS, the Tohono O'odham Nation Planning and Economic Development Department**
15 **has prepared and submits for approval a road construction contract with Black**
16 **and Yellow Paving LLC for road maintenance services on routes 19 and 191 for the**
17 **Roads Program Project PIR Road Maintenance within the Tohono O'odham**
18 **Nation; and**

19 **WHEREAS, the contract is for a flat fee of \$1,115,514.60; and**

20 **WHEREAS, the Agricultural and Natural Resources Committee has reviewed contract and**
21 **recommends approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **contract between the Tohono O'odham Nation and Black and Yellow Paving LLC,**
24 **in substantially the form attached.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to execute and**
27 **administer the contract, provided that any amendments or modifications shall**
28 **be submitted to the Tohono O'odham Legislative Council for prior approval.**




