Roads Program PIR 153 (1) & 1531 (1) North Komelik Community Loop  
Budget Amendment No. 2 No Cost Extension)**

**RESOLUTION NO. 25-215**

1   **WHEREAS,**    the Tohono O'odham Legislative Council is authorized "to manage any funds  
2                   within the exclusive control of the Tohono O'odham Nation ... and to appropriate  
3                   these funds for the benefit of the nation and its members" provided that "[a]ll  
4                   expenditures of these funds shall be pursuant to appropriations or budgets"  
5                   authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6                   Nation, Article VI, Section I (d)(2)); and

7   **WHEREAS,**    the FY 2023 Planning and Economic Development Department Roads Program  
8                   PIR 153 (1) & 1531 (1) North Komelik Community Loop Budget in the amount of  
9                   \$520,194.00 was approved by Legislative Council Resolution No.23-130; and

10   **WHEREAS,**   the FY 2024 Planning and Economic Development Department Roads Program  
11                  PIR 153 (1) & 1531 (1) North Komelik Community Loop Budget Amendment No. 1  
12                  which increased the budget by \$1,034,806.34, from \$520,194.00 to \$1,555,000.34,  
13                  was approved by Resolution 24-139; and

14   **WHEREAS,**    the Planning and Economic Development Department Roads Program has  
15                   received a no cost extension notice from the Bureau of Indian Affairs to extend  
16                   the PIR 153 (1) & 1531 (1) North Komelik Community Loop budget period of  
17                   performance effective December 06, 2022 through September 30, 2027; and

18   **WHEREAS,**    the Planning and Economic Development Department Roads Program has  
19                   prepared and submitted for review and approval its Planning and Economic  
20                   Development Department Roads Program PIR 153 (1) & 1531 (1) North Komelik  
21                   Community Loop Budget Amendment No. 2, which is incorporated by this  
22                   reference, and which will not change operational or capital line item(s); and

23   **WHEREAS,**    the Agricultural and Natural Resources and Budget and Finance Committees  
24                   have reviewed the Planning and Economic Development Department Roads  
25                   Program PIR 153 (1) & 1531 (1) North Komelik Community Loop Budget  
26                   Amendment No. 2 and recommend approval.

27   **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
28                   Planning and Economic Development Department Roads Program PIR 153 (1) &  
29                   1531 (1) North Komelik Community Loop Budget Amendment No. 2 which will  
30                   extend the budget period effective December 06, 2022 through September 30,  
31                   2027.
