

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 150-82, 142-89, 389-89, 03-153,  
09-369, 12-001, 17-259, 20-063, 21-088, 21-416, 24-259 and 25-001  
to Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 25-228**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the  
6 Enrollment Committee shall review membership applications and make a  
7 written recommendation to the Tohono O'odham Legislative Council to approve  
8 or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment  
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11 O'odham Legislative Council shall determine eligibility for membership or  
12 adoption; and

13 **WHEREAS,** the Enrollment Program has received official documents reflecting the legal  
14 name changes of enrolled members as a result of marriage, divorce, legal  
15 adoption, or for other reasons; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 150-82, 142-89, 389-  
17 89, 03-153, 09-369, 12-001, 17-259, 20-063, 21-088, 21-416, 24-259 and 25-001 be  
18 amended to reflect the legal name changes of members identified in the August  
19 2025 Legal Enrollment Resolution Summary, which is incorporated by this  
20 reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22 Nos. 150-82, 142-89, 389-89, 03-153, 09-369, 12-001, 17-259, 20-063, 21-088, 21-416,  
23 24-259 and 25-001 are amended upon the effective date of those resolutions to  
24 reflect the legal name changes of members identified in the August 2025 Legal  
25 Enrollment Resolution Summary.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>  
27 day of AUGUST, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-  
28 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by  
29 Article II, Sections 1 and 2 and Article VI, Section 1(h) Constitution of the Tohono O'odham  
30 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
32 16 of the Act of June 18, 1934 (48 Stat.984).






