14		membership and adoption applications misspelled or incorrectly listed the
15		names of members and/or incorrectly listed enrollment numbers; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 08-100, 10-070, 10-
17		401, 11-121 and 14-001 be amended to reflect the correct name and/or enrollment
18		number for the members identified in the August 2025 Corrected Enrollment
19		Resolution Summary, which is incorporated by this reference.
