7	WHEREAS,	on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
8		"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
9		per capita payments to the Nation's members, provided that sufficient gaming
0		revenues are available; and
1	WHEREAS,	the Ordinance for the Regulation of Gaming Activities Within the Tohono
2		O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize
3		per capita distribution payments in accordance with the Initiative (Legislative
4		Council Resolution No. 97-303); and
5	WHEREAS,	the Trust Agreement with Principal Trust Company requires that a listing of all
6		minor beneficiaries turning 18 that month be presented to the Tohono O'odham
7		Legislative Council to obtain approval to distribute the trust funds to these
8		eligible minor members as they are no longer restricted beneficiaries; and
9	WHEREAS,	by Resolution Nos. 24-156 and 25-173 the Tohono O'odham Legislative Council
0.0		approved the Monthly Age 18 Reports for June 2024 and June 2025 of eligible
1		minor members who reached the age of 18 and are no longer restricted from
22		receiving their per capita payments; and
23	WHEREAS,	the Nation's Enrollment Office has identified incorrect names for members on
24		the Monthly Age 18 Reports for June 2024 and June 2025 and recommends that the
2.5		names of the members be corrected in accordance with the Monthly Age 18
26		Report Amendment Summary August 2025, which is incorporated by this

28	WHEREAS,	the Rules Committee has reviewed the Enrollment Office's recommendations
