

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2025 Tohono O'odham Nation Health Care Budget Amendment**  
**No. 1 – Health Care Property and Supply Third Party)**

**RESOLUTION NO. 25-234**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance; and "to adopt, approve and amend annual  
6 budgets and to authorize the expenditure of funds in accordance with these  
7 budgets" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)  
8 and (3)); and

9 **WHEREAS,** Tohono O'odham Nation Health Care's ("TONHC") FY 2025 Budgets in the amount  
10 of \$150,500,365.98 were approved by Resolution No. 24-312; and

11 **WHEREAS,** TONHC's FY 2025 Budgets were then increased to the amount of \$153,811,010.04  
12 by Resolution No. 25-045 and again to \$153,867,138.21 by Resolution No. 25-053;  
13 and

14 **WHEREAS,** TONHC has prepared and submitted for review and approval budget  
15 amendments to its FY 2025 Budgets (collectively referred to as Budget  
16 Amendment No. 1) detailed below, which will adjust operational and/or  
17 personnel line items in the budgets as follows:

Tohono O'odham Legislative Council.


