9	WHEREAS,	Tohono O'odham Nation Health Care's ("TONHC") American Rescue Plan Act
10		("ARPA") Lost Reimbursement Budget in the amount of \$19,034,930.00 was
11		approved by Resolution No. 22-107 on March 14, 2022; and
12	WHEREAS,	TONHC's ARPA Lost Reimbursement Budget was later amended by Resolution No.
13		23-019 on January 13, 2023; and
14	WHEREAS,	TONHC's ARPA Lost Reimbursement Budget period was then extended by
15		Resolution No. 23-404 on October 12, 2023; and
16	WHEREAS,	TONHC's ARPA Lost Reimbursement Budget was again amended and extended by
17		Resolution No. 24-425 on December 17, 2024; and
18	WHEREAS,	TONHC has submitted for review and approval another ARPA Lost
19		Reimbursement Budget request to amend Resolution 24-425 to extend the hudget
20		period into FY 2026-2027 to allow any remaining available funds to be expended;
21		and
22	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
23		reviewed TONHC's request and recommend that Resolution 24-425 be amended
24		to extend the budget period through September 30, 2027 as requested to allow any
25		remaining available funds to be expended.
