13	WHEREAS,	the FY2025 Department of Health and Human Services Behavioral Health Bndget
14		Amendment No. 1 will increase the Department of Health and Human Services FY
15		2025 Rehavioral Health Budget by \$1,443.00 from \$3,423,815.29 to \$3,425,258.29;

17	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
18		reviewed the FY 2025 Department of Health and Human Services Behavioral
19		Health Budget Amendment No. 1 and recommend its approval.
