

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2025 Department of Health and Human Services Division of**  
**Child Welfare Children's Home Budget Amendment No. 1)**

**RESOLUTION NO. 25-239**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2025 Department of Health and Human Services Division of Child Welfare**  
8 **Children's Home Budget in the amount of \$1,329,821.46 was approved by**  
9 **Resolution No. 24-313; and**

10 **WHEREAS, the Department of Health and Human Services Division of Child Welfare has**  
11 **prepared and submitted for review and approval its FY 2025 Children's Home**  
12 **Budget Amendment No. 1, which is incorporated by this reference and which will**  
13 **adjust operational and personnel line items which will not change the budget**  
14 **amount; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
16 **reviewed the FY 2025 Department of Health and Human Services Division of Child**  
17 **Welfare Children's Home Budget Amendment No.1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2025 Department of Health and Human Services Division of Child Welfare**  
20 **Children's Home Budget Amendment No. 1 effective October 1, 2024 ending**  
21 **September 30, 2025 in the amount of \$1,329,821.46 which shall be funded by the**  
22 **Nation's general fund.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2025 Department of Health and Human Services Division of Child**  
26 **Welfare Children's Home Budget Amendment No. 1 as amended, provided that**  
27 **any amendments or modifications shall be submitted for prior approval by the**  
28 **Tohono O'odham Legislative Council.**
