

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2025 Department of Health and Human Services Division of**  
**Child Welfare Title IV-B Subparts 1 and 2 Budget Amendments No. 1)**

**RESOLUTION NO. 25-240**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2025 Department of Health and Human Services Division of Child Welfare  
8 Title IV-B Subparts 1 and 2 Budgets in the total amount of \$394,220.00 were  
9 approved by Resolution No. 24-308; and

10 **WHEREAS,** the Department of Health and Human Services Division of Child Welfare has  
11 prepared and submitted for review and approval its FY 2025 Title IV-B Subparts 1  
12 and 2 Budget Amendments No. 1, which are incorporated by this reference, and  
13 which will adjust operational line items and indirect costs; and

14 **WHEREAS,** the FY 2025 Department of Health and Human Services Division of Child Welfare  
15 Title IV-B Subparts 1 and 2 Budget Amendments No. 1 will decrease the  
16 Department of Health and Human Services Division of Child Welfare Title IV-B  
17 subparts 1 and 2 by \$57,370.00 from \$394,220.00 to \$336,850.00; and

18 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
19 reviewed the FY 2025 Department of Health and Human Services Division of Child  
20 Welfare Title IV-B Subparts 1 and 2 Budget Amendments No. 1 and recommend  
21 their approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
23 FY 2025 Department of Health and Human Services Division of Child Welfare Title  
24 IV-B Subparts 1 and 2 Budget Amendments No. 1 effective October 1, 2024, which  
25 includes a \$57,370.00 decrease from \$394,220.00 to \$336,850.00 as follows:

26 1. Title IV-B Subpart 1 Budget will decrease by \$20,037.00, from \$159,120.00 to  
27 \$139,083.00.

28 2. Title IV-B Subpart 2 Budget will decrease by \$37,333.00, from \$235,100.00 to  
29 \$197,767.00,

30 which shall be funded by the Nation's general fund pending reimbursement from  
31 the grantor, the United States Department of Health and Human Services
