

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving a No Cost Extension for FY 2024 Department of Health and Human Services**

**RESOLUTION NO. 25-244**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation... and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1 (d) (2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services Division of Senior Services  
8 Title VI Part C Caregivers American Rescue Plan Budget in the amount of  
9 \$55,340.00 was approved by Resolution No. 21-464; and

10 **WHEREAS,** the Department of Health and Human Services Division of Senior Services has  
11 received a no cost extension notice from the United States Department of Health  
12 and Human Services Administration for Community Living to extend the Title VI  
13 Part C Caregivers American Rescue Plan budget award through September 30,  
14 2025; and

15 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
16 review and approval its FY 2025 Division of Senior Services Title VI Part C  
17 Caregivers American Rescue Plan Budget, which is incorporated by this  
18 reference, in the amount of \$752.68 to be funded by the Nation's General Fund  
19 pending reimbursement from the grantor, the United States Department of  
20 Health and Human Services Administration for Community Living; and

21 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
22 reviewed the no cost extension for the FY 2024 Department of Health and Human  
23 Services Division of Senior Services Title VI Part C Caregivers American Rescue  
24 Plan Budget and FY 2025 Department of Health and Human Services Division of  
25 Senior Services Title VI Part C Caregivers American Rescue Plan Budget through  
26 September 30, 2025 and recommend its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
28 no cost extension for the FY 2024 Department of Health and Human Services  
29 Division of Senior Services Title VI Part C Caregivers American Rescue Plan and  
30 FY 2025 Department of Health and Human Services Division of Senior Services  
31 Title VI Part C Caregivers American Rescue Plan Budget effective May 1, 2021

through September 30, 2025 in the amount of \$752.68 which shall be funded by the Nation's General Fund pending reimbursement from the grantor, the United States Department of Health and Human Services Administration for Community Living.

**BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2025 Department of Health and Human Services Division of Senior Services Title VI Part C Caregivers American Rescue Plan Budget, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.






