

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Department of Education Vocational Rehabilitation  
Grant Budget Amendment No. 1)**

**RESOLUTION NO. 25-267**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2025 Department of Education Vocational Rehabilitation Grant Budget in  
8 the amount of \$450,723.00 was approved by Resolution No. 24-292; and

9 **WHEREAS,** the Department of Education has prepared and submitted for review and  
10 approval its FY 2025 Vocational Rehabilitation Grant Budget Amendment No. 1,  
11 which is incorporated by this reference and which will adjust operational,  
12 personnel, and indirect cost line items; and

13 **WHEREAS,** the FY 2025 Department of Education Vocational Rehabilitation Grant Budget  
14 Amendment No. 1 will not change the Department of Education FY 2025  
15 Vocational Rehabilitation Grant budget amount of \$450,723.00; and

16 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
17 reviewed the FY 2025 Department of Education Vocational Rehabilitation Grant  
18 Budget Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2025 Department of Education Vocational Rehabilitation Grant Budget  
21 Amendment No. 1 effective October 1, 2024, which does not change the 2025  
22 Vocational Rehabilitation Grant Budget amount of \$450,723.00 that shall be  
23 funded by the Nation's general fund pending reimbursement from the grantor,  
24 the United States Department of Education.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2025 Department of Education Vocational Rehabilitation Grant  
28 Budget as amended, provided that any amendments or modifications shall be  
29 submitted for prior approval by the Tohono O'odham Legislative Council.
