

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Chukut Kuk District Ak Komelik Community Budget Amendment No. 1)

RESOLUTION NO. 25-273

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2025 Chukut Kuk District Budget in the amount of \$2,766,737.92 was
13 authorized by Chukut Kuk District Resolution No. 2024-29 and approved by
14 Legislative Council Resolution No. 24-331; and

15 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2025-12, the Chukut Kuk District
16 has authorized and submitted for review and approval its FY 2025 Chukut Kuk
17 District Ak Komelik Community Budget Amendment No. 1, which is incorporated
18 by this reference and which will adjust operational and/or personnel line items;
19 and

20 **WHEREAS,** the FY 2025 Chukut Kuk District Ak Komelik Community Budget Amendment No.
21 1 will increase the FY 2025 Chukut Kuk District Ak Komelik Community Budget by
22 \$34,991.68 from \$20,000.00 to \$54,991.68; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Chukut Kuk District
24 Ak Komelik Community Budget Amendment No. 1 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2025 Ak Komelik Community Budget Amendment No. 1, effective October 1,
27 2024, which includes a \$34,991.68 increase from \$20,000.00 to \$54,991.68 that
28 shall be funded as follows:

- 29 (1) FY 2018 carryover funds in the amount of \$5,573.31;
30 (2) FY 2019 carryover funds in the amount of \$3,929.13;
31 (3) FY 2020 carryover funds in the amount of \$12,156.57; and
32 (4) FY 2021 carryover funds in the amount of \$13,332.67.



BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 Chukut Kuk District Ak Komelik Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH day of AUGUST, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


