**RESOLUTION NO. 25-276** 

1 WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham 2 Nation, 3 No district council shall expend district funds except pursuant to budgets 4 authorized under resolutions of the district council and approved by the 5 Tohono O'odham Council. The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. the FY 2021-FY 2025 Chukut Kuk District American Rescue Plan Act Budget in the 13 amount of \$4.507.948.00 was authorized by Chukut Kuk District Council 14 Resolution No. 2023-12 and approved by Legislative Council Resolution No. 23-121 15 for the budget period March 11, 2021 through December 31, 2024; and 16 by Chukut Kuk District Council Resolution No. 2025-16, the Chukut Kuk District WHEREAS. 17 approved extending the budget period for the FY 2021-2025 Chukut Kuk District 18 American Rescue Plan Act Budget through December 31, 2026; and 19 WHEREAS, by Chukut Kuk District Council Resolution No. 2025-19, the Chukut Kuk District 20 bas authorized and submitted for review and approval its FY 2021-FY 2027 Chukut 21 Kuk District American Rescue Plan Act Budget Amendment No. 1, which is 22 incorporated by this reference and which will adjust operational and/or 23 personnel line items; and 24 WHEREAS. the FY 2021-FY 2027 Chukut Kuk District American Rescue Plan Act Budget 25 Amendment No. 1 will not change the original budget amount of \$4,507,948.00; 26 and 27 WHEREAS, the Budget and Finance Committee has reviewed the FY 2021-FY 2027 Chukut Kuk 28 District American Rescue Plan Act Budget Amendment. No. 1 and recommends its 29 approval. 30 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odbam Legislative Council approves the 31 FY 2021-FY 2027 Chukut Kuk District American Rescue Plan Act Budget 32 Amendment No. 1, which will not change the budget amount of \$4,507,948.00.00.

RESOLUTION NO. 25-276 (Approving FY 2021-FY 2027 Chukut Kuk District American Rescue Plan Act Budget Amendment No. 1 and Extending Budget Period) Page 2 of 3 and approves extending the budget period effective March 11, 2021 through December 31, 2026. BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021-FY 2027 Chukut Kuk District American Rescue Plan Act Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the  $12^{TH}$ 

day of AUGUST, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odbam Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
