

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Professional Service Agreement Between the Tohono O'odham
Nation and Casa Grande Elementary School District #4)

RESOLUTION NO. 25-278

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "consult,
2 negotiate, and conclude agreements and contracts on behalf of the Tohono
3 O'odham Nation with Federal, State and local governments and other Indian
4 tribes or their departments, agencies, or political subdivisions" and "to promote,
5 protect and provide for public health...education and general welfare of the
6 Tohono O'odham Nation and its members" (Constitution of the Tohono O'odham
7 Nation, Article VI, Sections 1(c)(2) and (f); and

8 **WHEREAS,** the Department of Education, Childcare Services Program wishes to enter into a
9 Professional Services Agreement with Casa Grande Elementary School District #4
10 to provide childcare services for the Nation's children who are eligible to receive
11 childcare services; and


12 **WHEREAS,** the Human Resources Development Committee has reviewed the FY 2025
13 Professional Services Agreement and recommends its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2025 Department of Education Childcare Services Program Professional
16 Services Agreement with Casa Grande Elementary School District #4, in
17 substantially the form attached.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to execute and
20 administer the FY 2025 Professional Services Agreement with Casa Grande
21 Elementary School District #4, provided that any amendments or modifications
22 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12th
24 day of AUGUST, 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
25 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
26 Article VI, Section 1(c)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by
27 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
29 18, 1934 (48 Stat.984).




