4		organizations on all matters within the authority of the Tohono O'odham
5		Council" and "[t]o exercise the inherent powers of the Tohono O'odham Nation by
6		providing resolutions to promote, protect and provide for public health,
7		peace, morals, education and general welfare of the Tohono O'odham Nation and
8		its members" (Constitution of the Tohono O'odham Nation, Article VI, Section l(f)
9		and Article VI, Section 1(c)(2)); and
10	WHEREAS,	the Nation's Police Department ("TOPD") dispatch consoles require updates; and
11	WHEREAS,	TOPD desires to enter into a Professional Services Agreement with Motorola
12		Solutions, Inc. to upgrade its dispatch consoles; and
13	WHEREAS,	the Agreement may require a limited waiver of sovereign immunity because it
14		contains restrictions in the indemnification clause; and
15	WHEREAS,	the Agreement is a multi-year contract which shall continue through September
16		30, 2026; and
17	WHEREAS,	the Domestic Affairs Committee has reviewed the Professional Services
18		Agreement Between the Tohono O'odbam Nation and Motorola Solutions, Inc.
19		and recommends its approval.
20	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
21		Professional Services Agreement Between the Tohono O'odham Nation and
22		Motorola Solutions, Inc.
23	BE IT FURTI	HER RESOLVED that the Tohono O'odham Legislative Council approves in favor of
24		Motorola Solutions, Inc. a limited waiver of sovereign immunity hecause the
25		Professional Services Agreement Between the Tohono O'odham Nation and
26		Motorola Solutions, Inc. contains restrictions in the indemnification clause.
27	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
28		Nation Chairperson or any designated official is authorized to execute the
29		Professional Services Agreement Between the Tohono O'odham Nation and
30		Motorola Solutions, Inc. with a multiyear Agreement effective budget fiscal year
31		2025 through budget fiscal year 2026, substantially in the form attached hereto
