15		adoption, or for other reasons; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 23-82, 215-88, 92-
17		208, 94-109, 97-144, 98-123, 2000-035, 04-350, and 11-158 be amended to reflect
18		the legal name changes of members identified in the September 2025 Legal
19		Enrollment Resolution Summary, which is incorporated by this reference.
