

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 96-486, 98-429, 01-133, 08-456, 09-066, 10-070, 10-462, 18-001, 24-332, and 25-106 to Correct Names and/or Dates of Birth of Enrolled Members)

RESOLUTION NO. 25-291

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names and/or dates of birth of members; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 96-486, 98-429, 01-
17 133, 08-456, 09-066, 10-070, 10-462, 18-001, 24-332, and 25-106 be amended to
18 reflect the correct name and/or date of birth of the members identified in the
19 September 2025 Corrected Enrollment Resolution Summary, which is
20 incorporated by this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 96-486, 98-429, 01-133, 08-456, 09-066, 10-070, 10-462, 18-001, 24-332, and 25-
23 106 are amended upon the effective date of those resolutions to reflect the correct
24 name and/or date of birth of members identified in the September 2025
25 Corrected Enrollment Resolution Summary.


26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH

30 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
32 16 of the Act of June 18, 1934 (48 Stat.984).
