

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022-2027 San Xavier District American Rescue Plan Act Budget  
Amendment No. 2)**

**RESOLUTION NO. 25-293**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2022-FY 2027 San Xavier District American Rescue Plan Act ("ARPA") Budget  
13 in the amount of \$3,110,433.00 was authorized by San Xavier District Council  
14 Resolution No. SXDC 02-24-06 and approved by Legislative Council Resolution No.  
15 22-104, and subsequently amended by Legislative Council Resolution No. 23-419;  
16 and

17 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 08-25-02, the San Xavier  
18 District has authorized and submitted for review and approval its FY 2022-2027  
19 San Xavier District ARPA Budget Amendment No. 2, which is incorporated by this  
20 reference and which will adjust operational and/or personnel line items; and

21 **WHEREAS,** the FY 2022-2027 San Xavier District ARPA Budget Amendment No. 2 will not  
22 change the total budget amount of \$3,110,433.00; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022-2027 San Xavier  
24 District ARPA Budget Amendment No. 2 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
26 FY 2022-2027 San Xavier District American Rescue Plan Act Budget Amendment  
27 No. 2 effective March 11, 2021, which will not change the total budget amount of  
28 \$3,110,433.00.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022-2027 San  
30 Xavier District ARPA Budget as amended shall be managed and expended in  
31 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
32 Nation and the Nation's laws, provided that any amendments or modifications





shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.




