

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Natural Resources Range Conservation and
Management Program Lower Elevation Boundary Fence Repair Project Budget)**

RESOLUTION NO. 25-320

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources Range Conservation and Management**
8 **Program has prepared and submitted for review and approval its FY 2026 Lower**
9 **Elevation Boundary Fence Repair Project Budget, which is incorporated by this**
10 **reference, in the amount of \$2,404,230.18 to be funded from the Range and**
11 **Agriculture Fund; and**

12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
13 **have reviewed the FY 2026 Department of Natural Resources Range Conservation**
14 **and Management Program Lower Elevation Boundary Fence Repair Project**
15 **Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2026 Department of Natural Resources Range Conservation and Management**
18 **Program Lower Elevation Boundary Fence Repair Project Budget in the amount**
19 **of \$2,404,230.18, effective October 1, 2025 to be funded from the Range and**
20 **Agriculture Fund.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2026 Department of Natural Resources Range Conservation and**
24 **Management Program Lower Elevation Boundary Fence Repair Project Budget,**
25 **provided that any amendments or modifications shall be submitted for prior**
26 **approval by the Tohono O'odham Legislative Council.**


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
28 **day of SEPTEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**


