11		general fund; and			
12	WHEREAS,	The New Ranger Program includes a one time funding in the amount of			
13		\$500,000.00 for capital purchase; and			
14	WHEREAS,	the designated oversight committees for the respective departments and			
15		programs and Budget and Finance Committee have reviewed the FY 2026			
16		Executive Branch Tribal Budgets and recommend its approval.

18		FY 2026 Executive Branch Tribal Budgets effective October 1, 2025 in the amount			
19		of \$131,179,228.57 which shall be funded by the Nation's general fund.
