The management of these funds shall be only by 7 a treasurer or other authorized officer of the district council who has 8 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham Q Nation, and all expenditures of these funds shall be by checks signed by such 10 treasurer or other authorized officer, and the chairman or vice chairman of 11 the district council. 12 13 ; and 14 WHEREAS, by San Xavier District Council Resolution No. SXDC 08-25-01, the San Xavier 15 District has authorized its FY 2026 San Xavier District Budget, which is 16 incorporated by this reference, in the amount of \$14,474,890.60; and 17 WHEREAS, the Budget and Finance Committee has reviewed the FY 2026 San Xavier District 18 Budget and recommends its approval. 19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 20 FY 2026 San Xavier District Budget effective October 1, 2025 in the amount of 21 \$14,474,890.60, which shall be funded by: 22 Gaming Revenue Funds in the amount of \$8,443,334.54; 23 2. Cypress Mine Allocation in the amount of \$245,076.35; 24 3. ASARCO Lease Proceeds in the amount of \$6,401.35; 25 Grant Funds in the amount of \$2,189,087.68; and 4. 26 District Operating Account funds in the amount of \$3,590,990.68. 27 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026 San Xavier District Budget shall be managed and expended in accordance with Article 28 29 IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under 30 District Council resolution and submitted for prior approval by the Tohono 31

O'odham Legislative Council.
