

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Continuing Resolution for FY 2025 Sells District Budgets)**

**RESOLUTION NO. 25-344**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3  
4 No district council shall expend district funds except pursuant to budgets  
5 authorized under resolutions of the district council and approved by the  
6 Tohono O'odham Council. The management of these funds shall be only by  
7 a treasurer or other authorized officer of the district council who has  
8 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham  
9 Nation, and all expenditures of these funds shall be by checks signed by such  
10 treasurer or other authorized officer, and the chairman or vice chairman of  
11 the district council.

14 **WHEREAS,** by Sells District Council Resolution No. SD-100-25, the Sells District has requested  
15 a continuation of the FY 2025 Sells District Budgets beyond the current fiscal year  
16 ending September 30, 2025 and until a FY 2026 Sells District Budget is approved;  
17 and

18 **WHEREAS,** there are sufficient funds in the Sells District accounts to continue Sells District  
19 operations for the Sells District administration and all communities; and

20 **WHEREAS,** the Budget and Finance Committee has reviewed the request from Sells District  
21 and recommends its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council authorizes  
23 continued expenditures of the FY 2025 Sells District Budgets by Sells District after  
24 September 30, 2025 and until a FY 2026 Sells District Budget is approved by  
25 Legislative Council resolution.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025 Sells  
27 District Budgets shall be managed and expended in accordance with Article IX,  
28 Section 7 of the Constitution of the Tohono O'odham Nation, Resolution No. 25-  
29 221, and the Nation's laws, provided that any amendments or modifications shall  
30 be authorized under District Council resolution and submitted for prior approval  
31 by the Tohono O'odham Legislative Council.




