

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025- FY 2030 Planning and Economic Development Department,
Children's Home Pre-Construction Project Budget Amendment No. 1)

RESOLUTION NO. 25-358

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds with
2 in the exclusive control of the Tohono O'odham Nation...and to appropriate these
3 funds for the benefit of the nation and its member" provided that "[a]ll
4 expenditures of these funds shall be pursuant to the appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** in 2021, Legislative Council approved Resolution No. 21-121 in support of the
8 Permanent Children's Home Project with the goal of establishing a children's
9 home within the Nation's lands for children in need of supportive housing and
10 care; and

11 **WHEREAS,** the FY 2025 - FY 2030 Planning and Economic Development Department
12 Children's Home Pre-Construction Project Budget in the amount of \$750,000.00
13 was approved by Resolution 23-311; and

14 **WHEREAS,** the Planning and Economic Development Department has prepared and
15 submitted for review and approval its FY 2025 - FY 2030 Planning and Economic
16 Development Department, Children's Home Pre-Construction Project Budget
17 Amendment No. 1, which is incorporated by this reference and which will adjust
18 operational and/or personnel line items; and

19 **WHEREAS,** the FY 2025 - FY 2030 Planning and Economic Development Department
20 Children's Home Pre-Construction Project Budget Amendment No. 1 will not
21 change the total amount of the Planning and Economic Development
22 Department FY 2025 - FY 2030 Children's Home Pre-Construction Project Budget;
23 and

24 **WHEREAS,** the Appropriations, Commerce, Health and Human Services, and Budget and
25 Finance Committees have each reviewed the FY 2025 - FY 2030 Planning and
26 Economic Development Department, Children's Home Pre-Construction Project
27 Budget Amendment No. 1 and recommend its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2025 - FY 2030 Planning and Economic Development Department, Children's
30 Home Pre-Construction Project Budget Amendment No. 1 effective March 15,
31 2022 through August 31, 2030, which will not change the total budget amount and
32 shall be funded by the Nation's general fund pending reimbursement from the




BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2025 - FY 2030 Planning and Economic Development Department Children's Home Pre-Construction Project Budget as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of OCTOBER 2025 at a meeting at which a quorum was present with a vote of 3,015.25 FOR; 305.85 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).






