

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendments to the Monthly Age 18 Reports for February 2025  
and June 2025 to Correct Names of Members)**

**RESOLUTION NO. 25-374**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**  
2 **Legislative Council with the power "to manage any funds within the exclusive**  
3 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
4 **benefit of the nation and its members" provided that "[a]ll expenditures of these**  
5 **funds shall be pursuant to appropriations or budgets" authorized by resolution**  
6 **or ordinance (Constitution, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
8 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**  
9 **per capita payments to the Nation's members, provided that sufficient gaming**  
10 **revenues are available; and**

11 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
12 **O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize**  
13 **per capita distribution payments in accordance with the Initiative (Legislative**  
14 **Council Resolution No. 97-303); and**

15 **WHEREAS, the Trust Agreement with Principal Trust Company requires that a listing of all**  
16 **minor beneficiaries turning 18 that month be presented to the Tohono O'odham**  
17 **Legislative Council to obtain approval to distribute the trust funds to these**  
18 **eligible minor members as they are no longer restricted beneficiaries; and**

19 **WHEREAS, by Resolution Nos. 25-031 and 25-173, the Tohono O'odham Legislative Council**  
20 **approved the Monthly Age 18 Reports for February 2025 and June 2025 of eligible**  
21 **minor members who reached the age of 18 and are no longer restricted from**  
22 **receiving their per capita payments; and**

23 **WHEREAS, the Nation's Enrollment Office has identified incorrect names for members on**  
24 **the Monthly Age 18 Reports for February 2025 and June 2025 and recommends**  
25 **that the names of the members be corrected in accordance with the Monthly Age**  
26 **18 Report Amendment Summary October 2025, which is incorporated by this**  
27 **reference; and**

28 **WHEREAS, the Rules Committee has reviewed the Enrollment Office's recommendations**  
29 **and recommends approval.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
31 **amending the Monthly Age 18 Report for February 2025, approved by Resolution**  
32 **No. 25-031, and the Monthly Age 18 Report for June 2025, approved by Resolution**



The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> day of OCTOBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


