

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2027 Legislative Branch Legislative Replacement Building
Supplemental Budget Amendment No. 1)**

RESOLUTION NO. 25-386

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2025-2027 Legislative Branch Legislative Replacement Building**
8 **Supplemental Budget in the amount of \$21,979,004.47 was approved by**
9 **Legislative Council Resolution No. 25 017; and**

10 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**
11 **2025-2027 Legislative Replacement Building Supplemental Budget Amendment**
12 **No. 1, which is incorporated by this reference, and which will adjust operational**
13 **and capital line items and amend the 7230 Lease/Rental line item narrative; and**

14 **WHEREAS, FY 2025-2027 Legislative Branch Legislative Replacement Building Supplemental**
15 **Budget Amendment No. 1 will increase the FY 2025-2027 Legislative Replacement**
16 **Building Supplemental Budget by \$4,000,000.00 from \$21,979,004.47 to**
17 **\$25,979,004.47; and**

18 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2025-2027 Legislative**
19 **Branch Legislative Replacement Building Supplemental Budget Amendment No.**
20 **1 and recommends its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2025-2027 Legislative Branch Legislative Replacement Building Supplemental**
23 **Budget Amendment No. 1, effective October 1, 2024 through September 30, 2027,**
24 **which includes a \$4,000,000.00 increase from \$21,979,004.47 to \$25,979,004.47**
25 **that shall be funded by Nation's general fund surplus.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Legislative Council chairperson or any designated official is authorized to**
28 **administer and expend the FY 2025-2027 Legislative Branch Legislative**
29 **Replacement Building Supplemental Budget as amended, provided that any**
30 **modifications shall be submitted to the Budget and Finance Committee for**
31 **approval on behalf of the Legislative Council and amendments shall be submitted**
32 **for approval by the Tohono O'odham Legislative Council.**
