10	WHEREAS,	the Nation's Investment Committee, which is comprised of the Legislative Council
11		Budget and Finance Committee, the Nation's treasurer, and Nation's
12		chairperson, is responsible for overseeing and making recommendations
13		concerning the Nation's investments and funds held by the United States on the
14		Nation's behalf; and
15	WHEREAS,	the Nation's investment manager, Bank of America Private Bank, in consultation
16		with the Nation's investment advisor and the Nation's Investment Committee, bas
17		developed the Investment Policy Statement for the Tohono O'odham Nation
18		Hospital Building Fund as dated October 2025 (the "Investment Policy
19		Statement"), which is incorporated herein by this reference; and
20	WHEREAS,	the Investment Committee recommends that the Legislative Council approve the
21		Investment Policy Statement.
22	NOW, THERE	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
23		Investment Policy Statement for the Tohono O'odham Nation Hospital Building
24		Fund and authorizes the Nation's chairperson to execute the Investment Policy
25		Statement and other documents that are reasonably necessary to implement this
