

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of November 2025)

RESOLUTION NO. 25-398

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received a**
7 **written statement from 04 tribal members whom have expressed their intent to**
8 **relinquish their membership with the Tohono O'odham Nation and the members**
9 **are identified in the November 2025 Relinquishment List, which is incorporated**
10 **by this reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**

12 **A member of the Nation may relinquish his membership in the**
13 **Nation by submitting a written statement clearly expressing an**
14 **intent to relinquish his membership to the Council, a copy of**
15 **which must be served on the committee. The written statement**
16 **must be signed by the person wishing to relinquish his membership**
17 **or, if a minor or incompetent, by the parent(s), guardian or other**
18 **person legally authorized to act on his behalf. Relinquishment**
19 **does not require the approval of the Council, but is effective upon**
20 **receipt of the statement by the Council and cannot be subsequently**
21 **denied. Upon recognition by the Council that the individual has**
22 **renounced his membership, his name shall be deleted from the**
23 **membership roll.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
25 **recognizes that the four individuals identified in the November 2025**
26 **Relinquishment List have relinquished their membership in the Tohono**
27 **O'odham Nation and orders the removal of their name from the Nation's**
28 **membership roll.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
30 **day of NOVEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**
31 **-0- AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the**
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**


