

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 97-144 and 21-068 to Reflect Legal
Name Changes of Enrolled Members)**

RESOLUTION NO. 25-399

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 97-144 and 21-068**
17 **be amended to reflect the legal name changes of members identified in the**
18 **November 2025 Legal Enrollment Resolution Summary, which is incorporated by**
19 **this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 97-144 and 21-068 are amended upon the effective date of those resolutions**
22 **to reflect the legal name changes of members identified in the November 2025**
23 **Legal Enrollment Resolution Summary.**


24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
25 **day of NOVEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**

29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**


