## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Rachel Frazier Johnson as a Judge Pro Tempore of the Tohono O'odham Judicial Court)

**RESOLUTION NO. 25-405** 

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the authority to appoint
2		judges to the Tohono O'odham Judicial Court (Constitution, Article VIII, Section
3		3); and
4	WHEREAS,	the Legislative Council "may upon the recommendation of the chief judge
5		appoint pro tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2,
6		Section 1201); and
7	WHEREAS,	"[n]otwithstanding the provisions of Section 1103(C) of this Chapter, a judge pro
8		tempore shall be of good moral character, a resident of Arizona for not less than
9		five years, and admitted to the practice of law in any State for not less than three
10		years preceding the appointment, except that pro tempore judges shall not hold
11		an elected office with any government or hold an appointed position with the
12		Tohono O'odham Nation or be employed by the Nation or any of its entities" (6
13		T.O.C. Chapter 1, Article 2, Section 1203); and
14	WHEREAS,	the term of a judge pro tempore "shall be set forth in the resolution of the
15		Legislative Council appointing the judge, but in no case shall the term be longer
16		than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and
17	WHEREAS,	the chief judge has submitted Rachel Frazier Johnson's resume, letter of interest,
18		and a letter of recommendation for her appointment as a judge pro tempore to
19		the Tohono O'odham Judicial Court; and
20	WHEREAS,	the Judiciary Committee, having legislative oversight of matters pertaining to the
21		Tohono O'odham Judicial Court, has reviewed Rachel Frazier Johnson's resume,
22		letter of interest, and the chief judge's letter of recommendation, and has no
23		recommendation.
24	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints
25		Rachel Frazier Johnson to the Tohono O'odham Judicial Court as a judge pro
26		tempore for a six-year term commencing on the effective date of this resolution.
