

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Health and Human Services Division of
Senior Services Title VI Part C Amendment No. 1)**

RESOLUTION NO. 25-406

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2026 Department of Health and Human Services Division of Senior
8 Services Title VI Part C Budget in the amount of \$200,015.32 was approved by
9 Resolution No. 25-082; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2026 Title VI Part C Budget Amendment No. 1, which is
12 incorporated by this reference, and which will adjust operational line items; and

13 **WHEREAS,** the FY 2026 Department of Health and Human Services Title VI Part C Budget
14 Amendment No. 1 will not cause a change to the original budget amount of
15 \$200,015.32; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2026 Department of Health and Human Services Division of
18 Senior Services Title VI Part C Budget Amendment No. 1 and recommend its
19 approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2026 Department of Health and Human Services Division of Senior Services
22 Title VI Part C Budget Amendment No.1 effective April 1, 2025 through March 31,
23 2026 for a total of \$200,015.32, which shall be funded by the Nation's general fund
24 pending reimbursement from the grantor, the Administration for Community
25 Living, pursuant to Title VI of the Older Americans Act of 1978.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend the FY 2026 Department of Health and Human Services Division of Senior
29 Services Title VI Part C Budget as amended, provided that any amendments or
30 modifications shall be submitted for prior approval by the Tohono O'odham
31 Legislative Council.


