1	WHEREAS,	the Legislative Council is vested with the power to "provide for, appoint, or
2	:	provide for the appointment of, and prescribe the duties and powers of
3		committees, boards, officers and agents" and "to promote, protect and provide
4		for public health, peace, morals, education and general welfare of the Tohono
5		O'odham Nation and its members" (Constitution of the Tohono O'odham Nation,
6		Article VI, Section 1(b) and Section 1(c)(2)); and
7	WHEREAS,	the Nation's Research Code, enacted May 23, 2013, established the Nation's
8		Institutional Review Board to review and consider research proposals from
9		researchers seeking to conduct research on the Nation (17 Tohono O'odham Code
10		Chapter 8 – Research Code); and
11	WHEREAS,	the Nation's Institutional Review Board is comprised of five enrolled members of
12	:	the Nation with sufficient education and experience within their respective fields
13		to effectively evaluate research proposals (17 Tohono O'odham Code Chapter 8,
14		Section 8104); and
15	WHEREAS,	Institutional Review Board members are nominated by the Nation's chairperson
16		and appointed by the Legislative Council to serve staggered three-year terms
17		expiring on September 30 of the third year, provided that the Legislative Council
18		may appoint three initial IRB members to a three-year term and two initial
19	-	members to two-year terms and all terms thereafter shall be for three years with
20		all members serving until replaced (17 Tohono O'odham Code Chapter 8, Section
21		8104(D)); and
22	WHEREAS,	Chairman Verlon Jose has nominated Dr. Matthew Ignacio, a member of the
23		Nation with sufficient education and experience in the field of academics, for the
24		Institutional Review Board; and
25	WHEREAS,	the Human Resources Development and Rules Committees have reviewed Dr.
26		Matthew Ignacio's resume, cover letter, and background investigation report and
27		recommend appointment.
28	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints Dr.
29		Matthew Ignacio, a member of the Nation with sufficient education and
30		experience in the field of academics under Section 8104(C)(3) of the Nation's
31		Research Code, to the Institutional Review Board for a two-year term beginning
32		on the effective date of this resolution and expiring September 30, 2027, provided
33		that he shall continue to serve until replaced.
