## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Extending Timeframe for Detailed Treasurer Drew Stevens to Serve)

**RESOLUTION NO. 25-412** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Nation's chairperson
2		with authority to appoint the Nation's treasurer, and other officers and heads of
3		all governmental departments with the approval of the Tohono O'odham
4		Legislative Council (Constitution, Article VII, Section 2(e)); and
5	WHEREAS,	the Appointed Officers law provides that "[n]o person shall perform the functions
6		of, or be compensated for performing the duties of, an appointed officer for more
7		than 180 consecutive or nonconsecutive days without approval of the
8		appointment by resolution. The chairperson and Council may agree to extend the
9		180-day period by resolution." (1 T.O.C. Chapter 4, Section 4003(G)); and
10	WHEREAS,	the Nation's chairperson initially detailed Drew Stevens to serve as the Nation's
11	, , , , , , , , , , , , , , , , , , , ,	treasurer on November 15, 2024 for a 180-day term ending on May 14, 2025, and

13		Mr. Stevens' term was extended for an additional 180-day period ending on

	WHEREAS,	the Nation's chairperson has provided a request to the Budget and Finance
15		Committee to extend Mr. Drew Stevens' detail as the Nation's treasurer and the
16		Budget and Finance Committee recommends the extension.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council extends the
18		timeframe for Drew Stevens to serve as the Nation's detailed treasurer for an
19		additional 180-day period until May 9, 2026, provided that nothing in this
20		resolution prevents the Nation's chairperson from presenting a Nation's
21		treasurer appointee in accordance with the Appointed Officers law.
