1	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
2		within the exclusive control of the Tohono O'odham Nation and to appropriate
3		these funds for the benefit of the nation and its members" provided that "[a]ll
4		expenditures of these funds shall be pursuant to appropriations or budgets"
5		authorized by resolution or ordinance (Constitution of the Tohono O'odham
6		Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the Tohono O'odham Nation intends to provide emergency financial relief to
8		provide Indiau General Welfare Assistance benefits in accordance with the
9		Nation's General Welfare Law, 22 T.O.C. Chapter 3, for the purposes of assisting
0		Nation members impacted by the high costs of the economy, federal shutdown
1		and the disruption of the Supplemental Nutrition Assistance Program ("SNAP")
2		benefits; and
3	WHEREAS,	this program reflects the Nation's exercise of its inherent sovereign right to
4		promote the general welfare of the Nation, its self-determination, culture, and
5		tradition, by providing general welfare assistance, including Indian general
6		welfare benefits within the meaning of Internal Revenue Code Section 139E; and
7	WHEREAS,	the Nation's Executive Office has prepared and submitted for review and
8		approval its FY 2026 Tohono O'odbam Nation Emergency Financial Relief Budget,
9		which is incorporated by this reference, in the total amount of \$22,500,000.00 to
20		be funded from the Nation's general fund surplus; and
21	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2026 Tohono O'odham
22		Nation Emergency Financial Relief Budget and recommends its approval.
23	NOW, THERE	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
24		1. approves the FY 2026 Tohono O'odham Nation Emergency Financial Relief
25		Budget effective October 1, 2025 through January 31, 2026, in the amount of
26		\$22,500,000.00, which shall be funded by the Nation's general fund surplus,
27		provided that any unspent funds shall be returned to the Nation's general
28		fund surplus; and
29		2. approves the Emergency Financial Relief Program Description and
30		Guidelines, which set eligibility requirements and exclude former Nation's
31		members who have relinquished.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2026 Tohono O'odham Nation Emergency Financial Relief Budget. provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH day of NOVEMBER 2025 at a meeting at which a quorum was present with a vote of 3.321.1 FOR: -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18. 1934 (48 Stat. 984).
