

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2026 Baboquivari District Fresno Canyon Community Budget  
Amendment No. 1)**

**RESOLUTION NO. 25-424**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2025 Baboquivari District Budget in the amount of \$5,373,205.73 was  
13 authorized by Baboquivari District Council Resolution No. 2025-B-95 and  
14 approved by Legislative Council Resolution No. 25-339; and

15 **WHEREAS,** by Baboquivari District Council Resolution No. 2025-B-95, the Baboquivari  
16 District Council has authorized and submitted for review and approval its FY 2026  
17 Baboquivari District Fresno Canyon Community Budget Amendment No. 1,  
18 which is incorporated by this reference, and which will adjust the major capital  
19 line item; and

20 **WHEREAS,** the FY 2026 Baboquivari District Fresno Canyon Community Budget Amendment  
21 No. 1 will increase the FY 2026 Baboquivari District Fresno Canyon Community  
22 Budget by \$78,219.62 from \$533,820.57 to \$612,040.19; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Baboquivari District  
24 Fresno Canyon Community Budget Amendment No. 1 and recommends its  
25 approval.

26 **NOW, THEREFORE BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27 FY 2026 Baboquivari District Fresno Canyon Community Budget Amendment No.  
28 1 effective October 1, 2025, which includes a \$78,219.62 increase from \$533,820.57  
29 to \$612,040.19 that shall be funded by FY 2025 carryover funds.

30 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026  
31 Baboquivari District Budget will be increased from \$5,373,205.73 to  
32 \$5,451,425.35.

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026  
2 Bahoquivari District Fresno Canyon Community Budget as amended shall be  
3 managed and expended in accordance with Article IX, Section 7 of the  
4 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that  
5 any amendments or modifications shall be authorized under District Council  
6 resolution and submitted for prior approval by the Tohono O'odham Legislative  
7 Council.


8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>  
9 day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;  
10 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
11 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
12 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
13 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
14 (48 Stat.984).






