

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Baboquivari District Choulic Community Home Budget)**

RESOLUTION NO. 25-425

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Baboquivari District Council Resolution No. 2025-B-94, the Baboquivari
13 **District has authorized the FY 2026 Baboquivari District Choulic Community**
14 **Home Budget, which is incorporated by this reference, in the amount of**
15 **\$73,452.38; and**

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026 Baboquivari District
17 **Choulic Community Home Budget and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2026 Baboquivari District Choulic Community Home Budget effective October**
20 **1, 2025 in the amount of \$73,452.38, which shall be funded by FY 2024 Baboquivari**
21 **District Choulic Community Budget carry forward funds.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2026**
23 **Baboquivari District Choulic Community Home Budget shall be managed and**
24 **expended in accordance with Article IX, Section 7 of the Constitution of the**
25 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
26 **modifications shall be authorized under District Council resolution and**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
29 **day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
31 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
