

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Education Child Care Services Program Coronavirus Response and Relief Supplemental Appropriations Act 21PCAZCCC5 Carry Forward Budget)

RESOLUTION NO. 25-427

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and
8 approval its FY 2026 Child Care Services Program Coronavirus Response and
9 Relief Supplemental Appropriations Act ("CRRSA") 21PCAZCCC5 Carry Forward
10 Budget, which is incorporated by this reference, in the amount of \$3,093,147.70 to
11 be funded by the Nation's general fund pending reimbursement from the United
12 States Department of Health and Human Services, Administration for Children
13 and Families; and

14 **WHEREAS,** the Human Resources Development Committee and Budget and Finance
15 Committee have reviewed the FY 2026 Department of Education Child Care
16 Services Program CRRSA 21PCAZCCC5 Carry Forward Budget and recommend its
17 approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2026 Department of Education Child Care Services Program Coronavirus
20 Response and Relief Supplemental Appropriations Act 21PCAZCCC5 Carry
21 Forward Budget effective October 1, 2025 through September 30, 2026 in amount
22 of \$3,093,147.70, which shall be funded by the Nation's General Fund pending
23 reimbursement from the Grantor, the United States Department of Health and
24 Human Services, Administration for Children and Families.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
26 Nation chairperson or any designated official is authorized to administer and
27 expend the FY 2026 Department of Education Child Care Services Program CRRSA
28 21PCAZCCC5 Carry Forward Budget, provided that any amendments or
29 modifications shall be submitted for prior approval by the Tohono O'odham
30 Legislative Council.


