

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of DECEMBER 2025)**

RESOLUTION NO. 25-429

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6 Ordinance No. 05-81 as amended the Enrollment Committee has received a
7 written statement from 04 tribal members whom have expressed their intent to
8 relinquish their membership with the Tohono O'odham Nation and the members
9 are identified in the December 2025 Relinquishment List, which is incorporated
10 by this reference; and

11 **WHEREAS,** pursuant to Article IX Section 1 of the Enrollment Ordinance,

13 **A member of the Nation may relinquish his membership in the**
14 **Nation by submitting a written statement clearly expressing an**
15 **intent to relinquish his membership to the Council, a copy of**
16 **which must be served on the committee. The written statement**
17 **must be signed by the person wishing to relinquish his membership**
18 **or, if a minor or incompetent, by the parent(s), guardian or other**
19 **person legally authorized to act on his behalf. Relinquishment**
20 **does not require the approval of the Council, but is effective upon**
21 **receipt of the statement by the Council and cannot be subsequently**
22 **denied. Upon recognition by the Council that the individual has**
23 **renounced his membership, his name shall be deleted from the**
24 **membership roll.**

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby
27 recognizes that the four individuals identified in the December 2025
28 Relinquishment List have relinquished their membership in the Tohono
29 O'odham Nation and orders the removal of their name from the Nation's
30 membership roll.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


