

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution Nos. 67-82, 129-83, 224-87, 141-88, 94-025, 97-144, 98-034, 2000-003, 03-339, 10-257, and 21-068 to Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 25-430**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the  
6 Enrollment Committee shall review membership applications and make a  
7 written recommendation to the Tohono O'odham Legislative Council to approve  
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment  
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11 O'odham Legislative Council shall determine eligibility for membership or  
12 adoption; and

13 **WHEREAS,** the Enrollment Program has received official documents reflecting the legal  
14 name changes of enrolled members as a result of marriage, divorce, legal  
15 adoption, or for other reasons; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 67-82, 129-83, 224-  
17 87, 141-88, 94-025, 97-144, 98-034, 2000-003, 03-339, 10-257, and 21-068 be  
18 amended to reflect the legal name changes of members identified in the  
19 December 2025 Legal Enrollment Resolution Summary, which is incorporated by  
20 this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22 Nos. 67-82, 129-83, 224-87, 141-88, 94-025, 97-144, 98-034, 2000-003, 03-339, 10-  
23 257, and 21-068 are amended upon the effective date of those resolutions to  
24 reflect the legal name changes of members identified in the December 2025 Legal  
25 Enrollment Resolution Summary.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
27 **day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
