

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution No. 08-035 to Correct the Name of One  
Enrolled Member)**

**RESOLUTION NO. 25-431**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members (Article II,  
3 Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono  
4 O'odham Nation); and

5 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the  
6 Enrollment Committee is responsible for reviewing enrollment applications and  
7 making recommendations to the Legislative Council regarding the eligibility of  
8 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

9 **WHEREAS,** Article VIII of the Nation's Enrollment Ordinance provides that the Tohono  
10 O'odham Legislative Council shall determine whether an application is approved  
11 for membership and its determination, along with the resolution number and  
12 date of enactment, shall be provided to the applicant; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving  
14 membership and adoption applications misspelled or incorrectly listed the  
15 names of members; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution No. 08-035 be amended to  
17 reflect the correct name for the member identified in the December 2025  
18 Corrected Enrollment Resolution Summary, which is incorporated by this  
19 reference.


20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
21 No. 08-035 is amended upon the effective date of the resolution to reflect the  
22 correct name for the member identified in the December 2025 Corrected  
23 Enrollment Resolution Summary.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
25 **day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
28 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
30 **16 of the Act of June 18, 1934 (48 Stat.984).**




