

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025-2027 Planning and Economic Development Department Roads
Program PIR 400(1) San Lucy Sidewalks & Street Lights Budget Amendment No. 3)**

RESOLUTION NO. 25-435

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefits of the nation and its members" provided that "all
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the FY2022 Planning and Economic Development Department Roads Program
8 PIR 400(1) San Lucy Design Street Lights and Sidewalks Project Budget in the
9 amount of \$117,174.68 was approved by Resolution No. 21-330; and

10 **WHEREAS,** the FY 2023 Planning and Economic Development Department Roads Program
11 San Lucy Sidewalks & Street Lights Budget Amendment No.1 in the amount of
12 \$117,174.68 was approved by Resolution No. 22-423; and

13 **WHEREAS,** the FY 2024 Planning and Economic Development Department Roads Program
14 San Lucy Sidewalks & Street Lights Budget Amendment No. 2 which increased the
15 budget by \$182,825.32 from \$117,174.68 to \$300,000.00 was approved by
16 Resolution No. 24-076; and

17 **WHEREAS,** the Planning and Economic Development Department Roads Program has
18 received a no cost extension notice from the Bureau of Indian Affairs to extend
19 the PIR 400(1) San Lucy Sidewalks & Street Lights Budget period of performance
20 through September 30, 2027; and

21 **WHEREAS,** the Planning and Economic Development Department Roads Program has
22 prepared and submitted for review and approval its FY 2025-2027 PIR 400(1) San
23 Lucy Sidewalks & Street Lights Budget Amendment No. 3 which is incorporated by
24 this reference, and which will adjust the operational and/or capital line items(s)
25 without change to the total budget; and

26 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
27 have reviewed the FY 2025-2027 Planning and Economic Development
28 Department Roads Program PIR 400(1) San Lucy Sidewalks & Street Lights Budget
29 Amendment No. 3 and the no cost extension and recommend approval.

30 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
31 no cost extension from the Bureau of Indian Affairs and approves the FY 2025-
32 2027 Planning and Economic Development Department Roads Program PIR
