

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 – FY 2027 Planning and Economic Development Department
Roads Program Santa Rosa Ranch Road PIR 35(2) Budget Amendment
No. 2 and Accepting No Cost Extension)**

RESOLUTION NO. 25-436

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation ... and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1 (d)(2)); and

7 **WHEREAS,** the FY 2023-FY 2024 Planning and Economic Development Department Roads
8 Program Santa Rosa Ranch Road PIR 35(2) Budget in the amount of \$700,000 was
9 approved by Legislative Council Resolution No. 23-131; and

10 **WHEREAS,** the FY 2024 Planning and Economic Development Department Roads Program
11 Santa Rosa Ranch Road PIR 35(2) Budget Amendment No. 1 which increased the
12 budget by \$100,000, from \$700,000 to \$800,000, was approved by Legislative
13 Council Resolution No. 24-075; and

14 **WHEREAS,** the Planning and Economic Development Department Roads Program has
15 received a no cost extension from the United States Bureau of Indian Affairs to
16 extend the budget performance period through September 30, 2027; and

17 **WHEREAS,** the Planning and Economic Development Department Roads Program has
18 prepared and submitted for review and approval it's FY 2026 - FY2027 Santa Rosa
19 Ranch Road PIR 35(2) Budget Amendment No. 2, which is incorporated by this
20 reference and which will adjust operational line items; and

21 **WHEREAS,** the Planning and Economic Development Department Roads Program Santa
22 Rosa Ranch Road PIR 35(2) Budget Amendment No. 2 total budget amount will
23 remain \$800,000 and will extend the budget performance period through
24 September 30, 2027; and

25 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
26 have reviewed the Planning and Economic Development Department Roads
27 Program Santa Rosa Ranch Road PIR 35(2) Budget Amendment No. 2 and no cost
28 extension and recommend its approval.

29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
30 FY 2026 – FY 2027 Planning and Economic Development Department Roads
31 Program Santa Rosa Ranch Road PIR 35(2) Budget Amendment No. 2 effective



1 January 17, 2023, which will not cause a change in the total budget amount, that
2 shall be funded by the Nation's general fund pending reimbursement from the
3 grantor, the United States Bureau of Indian Affairs and accepts the no cost
4 extension, which will extend the budget period through September 30, 2027.

5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
6 Nation chairperson or any designated official is authorized to administer and
7 expend the FY 2026 – FY 2027 Planning and Economic Development Department
8 Roads Program Santa Rosa Ranch Road PIR 35(2) Budget, as amended, provided
9 that any amendments or modifications shall be submitted for prior approval by
10 the Tohono O'odham Legislative Council.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
12 day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;
13 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
14 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
15 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17 18, 1934 (48 Stat.984).


