

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2026-FY 2027 Chukut Kuk District Supplemental Budget)**

**RESOLUTION NO. 25-440**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2025-30, the Chukut Kuk District  
13 Council has authorized the FY 2026-FY 2027 Chukut Kuk District Supplemental  
14 Budget, which is incorporated by this reference in the amount of \$5,577,658.28;  
15 and

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2026-FY 2027 Chukut Kuk  
17 District Supplemental Budget and recommends its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
19 FY 2026-FY 2027 Chukut Kuk District Supplemental Budget effective October 1,  
20 2025 in the amount of \$5,577,658.28, which shall be funded by Chukut Kuk District  
21 Investment Savings.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2026-FY 2027  
23 Chukut Kuk District Supplemental Budget shall be managed and expended in  
24 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
25 Nation and the Nation's laws, provided that any amendments or modifications  
26 shall be authorized under District Council resolution and submitted for prior  
27 approval by the Tohono O'odham Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>th</sup>  
29 day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 2,755.4 FOR;  
30 -0- AGAINST; 565.7[02] VOTING; and [02] ABSENT, pursuant to the powers vested in the Council  
31 by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the  
32 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
34 18, 1934 (48 Stat.984).
