

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Health and Human Services Division of Health
Transportation Service Program Revenue Funding Budget Amendment No. 1)

RESOLUTION NO. 25-448

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2026 Department of Health and Human Services Division of Health**
8 **Transportation Service Program Revenue Funding Budget in the amount of**
9 **\$4,338,123.32 was approved by Resolution No. 25-327; and**

10 **WHEREAS, the Department of Health and Human Services Division of Health Transportation**
11 **Service Program has prepared and submitted for review and approval its FY 2026**
12 **Revenue Funding Budget Amendment No. 1, which is incorporated by this**
13 **reference and which will adjust operational line items; and**

14 **WHEREAS, the FY 2026 Department of Health and Human Services Division of Health**
15 **Transportation Service Program Revenue Funding Budget Amendment No. 1 will**
16 **increase the Department of Health and Human Services FY 2026 Division of**
17 **Health Transportation Service Program Revenue Funding Budget by**
18 **\$529,246.68 from \$4,338,123.32 to \$4,867,370.00; and**

19 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
20 **reviewed the FY 2026 Department of Health and Human Services Division of**
21 **Health Transportation Service Program Revenue Funding Budget Amendment**
22 **No. 1 and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2026 Department of Health and Human Services Division of Health**
25 **Transportation Service Program Revenue Funding Budget Amendment No. 1**
26 **effective October 1, 2025, which includes a \$529,246.68 increase from**
27 **\$4,338,123.32 to \$4,867,370.00 that shall be funded by the Nation's Third Party**
28 **Revenue.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation chairperson or any designated official is authorized to administer and**
31 **expend the FY 2026 Department of Health and Human Services Division of Health**
32 **Transportation Service Program Revenue Funding Budget as amended, provided**


