

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2027 Department of Health and Human Services Healthy
O'odham Promotion Program Budget)**

RESOLUTION NO. 25-449

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2027 Healthy O'odham Promotion Program Budget,
9 which is incorporated by this reference, in the amount of \$2,241,130.00, to be
10 funded by the Nation's general fund pending reimbursement from the grantor,
11 the United States Department of Health and Human Services, Indian Health
12 Service, Special Diabetes Program for Indians; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2027 Department of Health and Human Services Healthy
15 O'odham Promotion Program Budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 FY 2027 Department of Health and Human Services Healthy O'odham Promotion
18 Program Budget effective January 1, 2026 through December 31, 2026 in the
19 amount of \$2,241,130.00, which shall be funded by the Nation's general fund
20 pending reimbursement from the grantor, the United States Department of
21 Health and Human Services, Indian Health Service, Special Diabetes Program for
22 Indians.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2027 Department of Health and Human Services Healthy O'odham
26 Promotion Program Budget, provided that any amendments or modifications
27 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
29 **day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
