

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Health and Human Services Komckud Ki:
Family Violence Prevention Services Act Grant Budget)**

RESOLUTION NO. 25-451

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2026 Komckud Ki: Family Violence Prevention Services
9 Act Grant Budget, which is incorporated by this reference, in the amount of
10 \$359,697.00 to be funded by the Nation's general fund pending reimbursement by
11 the grantor, the United States Department of Health and Human Services
12 Administration for Children and Families; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2026 Department of Health and Human Services Komckud Ki:
15 Family Violence Prevention Services Act Grant Budget and recommend its
16 approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 **FY 2026 Department of Health and Human Services Komckud Ki: Family Violence**
19 **Prevention Services Act Grant Budget effective October 1, 2025 in the amount of**
20 **\$359,697.00 which shall be funded by the Nation's general fund pending**
21 **reimbursement from the grantor, the United States Department of Health and**
22 **Human Services Administration for Children and Families.**

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2026 Department of Health and Human Services Komckud Ki:**
26 **Family Violence Prevention Services Act Grant Budget, provided that any**
27 **amendments or modifications shall be submitted for prior approval by the**
28 **Tohono O'odham Legislative Council.**


