

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY2026 - FY2027 Planning and Economic Development Department Roads  
Program PIR 3(2) Gunsight Loop Budget Amendment No. 1 and No Cost Extension)**

**RESOLUTION NO. 25-458**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefits of the nation and its members" provided that "all  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY2024 Planning and Economic Development Department Roads Program PIR  
8 3(2) Gunsight Loop Budget in the amount of \$799,997.94 was approved by  
9 Resolution No. 24-109; and

10 **WHEREAS,** the Planning and Economic Development Department Roads Program has  
11 received a no cost extension notice from the Bureau of Indian Affairs to extend the  
12 PIR 3(2) Gunsight Loop Budget period of performance through September 30,  
13 2027; and

14 **WHEREAS,** the Planning and Economic Development Department Roads Program has  
15 prepared and submitted for review and approval its FY2026 - FY2027 PIR 3(2)  
16 Gunsight Loop Budget Amendment No. 1 and No Cost Extension which is  
17 incorporated by this reference, and which will adjust operational and/or capital  
18 line items(s) but will not cause a change to the total budget amount of \$799,997.94;  
19 and

20 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees have  
21 reviewed the FY2026 - FY2027 Planning and Economic Development Department  
22 Roads Program PIR 3(2) Gunsight Loop Budget Amendment No. 1 and No Cost  
23 Extension and recommend approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves  
25 acceptance of the No Cost Extension from the Bureau of Indian Affairs, extending  
26 the performance period through September 30, 2027.

27 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council approves the FY2026 -  
28 FY2027 Planning and Economic Development Roads Program PIR 3(2) Gunsight  
29 Loop Budget Amendment No. 1 and No Cost Extension effective August 14, 2023  
30 through September 30, 2027 which shall be funded by the Nation's general fund  
31 pending reimbursement by the grantor, the Bureau of Indian Affairs.



4 **Roads Program PIR 3(2) Gunsight Loop Budget Amendment No. 1 and No Cost**  
5 **Extension, provided that any amendments or modifications shall be submitted**  
6 **for prior approval by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
8 **day of DECEMBER 2025 at a meeting at which a quorum was present with a vote of 3,321.1 FOR;**  
9 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
10 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
11 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
13 **18, 1934 (48 Stat.984).**




