RESOLUTION NO. 26-010

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Planning and Economic Development Department Roads Program Gu**
8 **Vo Loop Road Project PIR 1006(1) Budget in the amount of \$104,107.21 was**
9 **approved by Resolution No. 21-329; and**

10 **WHEREAS, the BIA Western Region Office awarded the Nation an additional \$1,609,049.76 for**
11 **the Planning and Economic Development Department Roads Program Gu Vo**
12 **Loop Road Project PIR 1006(1) for construction activities; and**

13 **WHEREAS, the FY 2022 Planning and Economic Development Department Roads Program Gu**
14 **Vo Loop Road Project PIR 1006(1) Budget Amendment No. 1, which increased the**
15 **budget by \$1,609,049.76 from \$104,107.21 to \$1,713,156.97 was approved by**
16 **Resolution 22- 018; and**

17 **WHEREAS, the FY 2024-2025 Planning and Economic Development Department Roads**
18 **Program Gu Vo Loop Road Project PIR 1006(1) Budget Amendment 2, which**
19 **provided a no cost extension to the budget period of performance through**
20 **September 30, 2025 was approved by Resolution No. 25-015; and**

21 **WHEREAS, the Planning and Economic Development Department Roads Program has**
22 **received a no cost extension notice from the Bureau of Indian Affairs via**
23 **Modification No. 11 to extend the FY 2026-2027 Gu Vo loop Road Project PIR**
24 **1006(1) budget period of performance through September 30, 2027; and**

25 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
26 **have reviewed the no cost extension and FY 2026-2027 Planning and Economic**
27 **Development Department Roads Program Gu Vo Loop Road Project PIR 1006(1)**
28 **Budget Amendment No. 3 in the amount of \$1,713,156.97 and recommend its**
29 **approval.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
31 **no cost extension and FY 2026-2027 Planning and Economic Development**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13th day of JANUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


