

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2026 Department of Education Education Administration
Budget Amendment No. 1)

RESOLUTION NO. 26-012

1 **WHEREAS**, the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS**, the FY 2026 Department of Education Education Administration Budget in the
8 amount of \$734,879.54 was approved by Resolution No. 25-335; and

9 **WHEREAS**, the Department of Education has prepared and submitted for review and
10 approval its FY 2026 Department of Education Education Administration Budget
11 Amendment No. 1, which is incorporated by this reference and which will adjust
12 and create operational line items; and

13 **WHEREAS**, the FY 2026 Department of Education Education Administration Budget
14 Amendment 1 will not change the original budget of \$734,879.54; and

15 **WHEREAS**, the Human Resources Development and Budget and Finance Committees have
16 reviewed the FY 2026 Department of Education Education Administration Budget
17 Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2026 Department of Education Education Administration Budget Amendment
20 No. 1 effective October 1, 2025, which adjusts and creates operational line items,
21 but does not change the original budget of \$734,879.54, that shall be funded by the
22 Nation's general fund.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2026 Department of Education Education Administration Budget,
26 as amended, provided that any amendments or modifications shall be submitted
27 for prior approval by the Tohono O'odham Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13th
29 day of JANUARY 2026 at a meeting at which a quorum was present with a vote of 3,321.1 FOR; -0-
30 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
31 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
32 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
34 18, 1934 (48 Stat.984).






